




# MONTHLY REPORT

## FEBRUARY ACTIVITIES

- We received the People Choice Award from the Flume for the 2022 "Best Fitness Place".

#### **MAINTENANCE & REPAIRS**

- We brought in 3 different companies to get their input on the complete removal of the old deck seal. Suggestions were made to media blast the deck. Log Home Finishing who specializes in media blasting was brough in and they recommended not to media blast the deck because of the damage it can cause. In March we decided to go with Top Gun Power Washing to finish the work. Their scrub brushes with vacuum didn't remove the leftover sealer. They had to use a regular power wash same as Mille Concrete did. However, they were able to use hot water with a chemical called Dicone 9 to remove the remainder sealer.
- Staff has been doing lots of cleaning and maintenance work in the pool area.
- The work for the installation of the auto fill system, that was approved by the board in 2021, was completed.

• I've been continuing my trainings with SDA for Designated Election Officials for the upcoming district elections.


#### **FINANCIAL**

- Carrie is working on a grant with Summit Foundation.


## FEBRUARY MONTHLY SALES REPORT

## **ISSUES + CONCERNS**

- On March 20th the work for sealing the pool deck was completed. There is still some minor work for finishing the grouting for deck seams and cracks which will be completed next weekend.
- We are filling the pool this week to have it open by this weekend.
- We discovered some major cracks and damages to the pool Dimond Bright surface. The suggested lifespan of Dimond Bright is 10-15 years max before a pool has to be resurfaced. Our pool was resurfaced in 2009, so it's been 13 years now. We are gathering quotes for resurfacing the pool, so we can budget for it this year to get the work done in 2023.









 Most of the lights bulbs for the lights in the parking lot are burnt out. We currently don't have these bulbs in stock and need to order them. I will provide you with some estimates once I've received pricing for these bulbs. It was recommended by Wave Electric that we look into replacing the light ballasts which will save us money in the long run. I will keep you posted on this.
