





## MONTHLY REPORT

## **APRIL ACTIVITIES**

In the month of April, we sold a total of **89** memberships, and **118** daily passes. The total sales for the month were \$\$7,423.35 (see attached Mindbody report).

#### **PROGRAMS**

- School Swim Lessons started the last week of April. 125 students enrolled. Generated \$5,000 from this program

#### **OPERATIONS**

- We held the Spring Icebreaker Open House on April 9th. We raised \$259.44. Please see the attached report provided by Carrie.
- We did a pool Easter Egg Hunt on 4/17. We had 25 kids and 5 adults in pool.
- We had lots of staff resignations in the months of April and May. We have been interviewing, hiring, and training new staff in the month of May.
- Completed the Employee Handbook updates (see attached)
- We still have not received a quote from Chris Benzee for the possible basketball/pickleball court.

#### **MAINTENANCE & REPAIRS**

- Resolved the minor issues with the new pool auto fill system and the system is working properly now.
- Received an estimate from Tolin on installing a new water fountain with a bottle filling option. The estimate was \$1,080 (8hrs x \$135/hr).

#### **INFORMATION TECHNOLOGY**

- We have digitized all of our daily chemical reading sheets, and the pool area daily cleaning/maintenance checklist.
- Researched other rec management software. In the month of May we received a quote from Club Automation (see attached).

Attended trainings for conducting the district elections in May.


#### **FINANCIAL & GRANTS**

- We applied for grants with the Colorado Park and Wildlife (\$50,000 for the purchase of a van), The Summit Foundation (\$5,000 for skate park repairs), and 2 funding requests from the Congressional Designated Spending (\$50,000 for climbing wall and \$20,000 for the construction of a new storage shed).
- Year to date Youth Program Income update (as of 5/22/2022):
  - o Dance: \$1,661
  - Soccer: \$1,869
  - Swim Lessons: \$6,796
- We have raised \$1,000 in soccer sponsorships so far.
- We now own QuickBooks Online including the payroll module.


## APRIL MONTHLY SALES REPORT






# ANNUAL COMPARISONS






The most common actions that customers take on your listing
