  - A. 2022 Projected Budget Open Items, Path to Finalize
    - i. COLA Pay increases part time and salary, Adelina increase, cleaning co cost
      - 1. Roughly 10% increase in funds from Property Tax expected. We should find out the end of November.
      - 2. Bond Payment Next year is the last year of payment. 1.86 mills will reduce to 1 mill once it's paid off.
      - Membership Rates Saam has a report for proposed rate increases.
         Totals amount to an approximate 10% increase. He also wants to standardize resident vs non-resident percentage increase. Denise motions to approve approximate 10% increase in membership fees; Matt 2nds; Motion Passed
      - 4. Pay Rates There are community difficulties in retaining staff that the Rec Center is experiencing as well. Saam and Carrie are proposing rate increases at each position.
      - 5. Adelina increasing her monthly rates. It will have a significant cost increase. Saam would like a standing weekly meeting. It's becoming increasingly hard with Adelina's travel schedule.
      - 6. Cleaning Company Saam reached out to five companies. One of those companies responded and set up an interview. 3 Hours to clean at approximately \$35/clean is too much. Saam would like to clean approximately 3x per week with a professional cleaning. Staff could clean other times of the week. Kevin motions to hire Big Mountain Services for cleaning 3x week at \$1250/mo; Cam 2nds; Motion passed

      - 1. We will revisit after Adelina returns.
